

Instructions to Apply for a Loogootee School Scholarship Trust Award

You must have at least a 2.0 cumulative grade point average after 7 semesters of high school and plan on attending an accredited college or vocational school on a full-time basis.

APPLICATION FORM: Complete all information and return to the principal's office no later than Friday, March 13, 2020. The application can be filled out online and then printed for signatures.

THREE REFERENCE FORMS: Give two of these forms to members of the Jr/Sr High School Staff (one of whom may be an administrator). The third is to be given to someone outside of the school who is NOT a relative. These can be printed from the computer or you can pick up a paper copy in the High School Office.

PARENTAL DATA/STUDENT DATA: Complete the "Parental Data-Student Data" sheet that deals with financial information. When completed, seal this form in an envelope marked "Loogootee School Scholarship Trust Financial Data" and return to the High School Office by Friday, March 13, 2020. This can be printed from the computer or you can pick up a paper copy in the high school office.
